UWKG is a local organization governed by a local board of directors and operates under charitable solicitation permit issued by the State of Tennessee (26). UWKG may deduct up to 4.6% of collected pledges for administrative costs for processing and distributing gifts, and up to 9.5% for fundraising costs.
